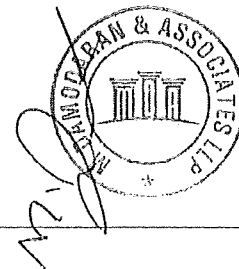

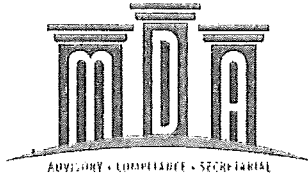

1. I, M. Damodaran, Managing Partner of M Damodaran & Associates LLP, Practicing Company Secretaries had been appointed as a Scrutinizer by the Board of Directors of **India Motor Parts & Accessories Limited** ("the Company") for scrutinizing the remote e-voting and e-voting by Members at the AGM pursuant to Section 108 of the Companies Act, 2013 ("the Act") read with Rule 20 of the Companies (Management and Administration) Rules, 2014 as amended ("Rules") and Regulation 44 of the SEBI (Listing Obligations & Disclosure Requirements) Regulations, 2015 ("SEBI Listing Regulations") in respect of the below mentioned resolutions proposed at the 66th AGM of the Members of the Company held on Monday, September 7, 2020 at 11:30 A.M through VC, submit my report as under:
2. The management of the Company is responsible to ensure the compliance with the requirement of the Act and Rules relating to voting through electronic means [i.e. by remote e-voting and e-voting by Members at the AGM] for the resolutions contained in the Notice of the 66th AGM of the Members of the company. My responsibility as a Scrutinizer for voting process of voting through electronic means (i.e by remote e-voting and e-voting by Members at the AGM) is restricted to make a consolidated Scrutinizer's Report of the vote cast "In favor "or "against" the resolution stated in the notice of the AGM, based on the report generated from the e-voting system provided by CDSL (Central Depository Services (India) Limited), engaged by the Company to provide e-voting facilities for voting through electronic means.

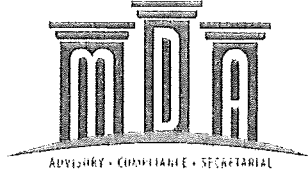

3. The remote e-voting commenced on September 3, 2020 (Thursday) at 09.00 A.M and ended on September 6, 2020 (Sunday) at 05.00 P.M.
4. The Members present at the AGM through VC voted through e-voting facility provided by CDSL at the AGM.
5. The Members holding shares as on August 28, 2020 (Friday), cut-off date, were entitled to vote on the resolutions stated in the Notice of the 66th Annual General Meeting of the Company.
6. As per the information given by the Company the names of the Members who had voted by remote e-voting through the facility provided by CDSL had been blocked and only those Members who were present at the AGM through VC and who had not voted on remote e-voting were allowed to cast their votes through e-voting system at the AGM.
7. On completion of e-voting at the AGM, the votes cast through remote e-voting and e-voting by Members at the AGM were unblocked and downloaded on September 7, 2020 at 12.46 P.M in presence of two witnesses who are not in the employment of the Company. The e-voting data/results downloaded from the e-voting system of CDSL were scrutinized and reviewed, the votes were counted, and the results were prepared.
8. Based on the data downloaded from CDSL e-voting system, the total votes cast in favor or against all the resolutions proposed in the Notice of the AGM are as under:

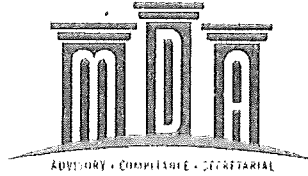

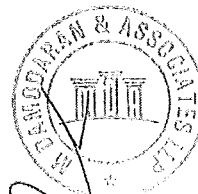
