RE-CLASSIFICATION OF M/S. T V SUNDRAM IYENGAR & SONS PRIVATE LIMITED AS "PUBLIC" FROM "PROMOTER"

The Directors perused the request received from M/s. T V Sundram Iyengar & Sons Private Limited ("TVSS") one of our promoters, seeking re-classification of their status as 'Public', along with rationale submitted by them for the said purpose. The Board took note that TVSS has confirmed that all the conditions specified in sub-clause (i) to (vii) of clause (b) of sub-regulation (3) of Regulation 31A of SEBI (LODR) Regulations, 2015, are duly complied with and that at all times from the date of such re-classification, they shall continue to comply with conditions mentioned Regulation 31A of SEBI (LODR) Regulations, 2015 post reclassification from "Promoter" to "Public".

Since, TVSS does not hold any shares in the Company the approval of the shareholders is not required, pursuant to Reg31A(3)(iii)(a) of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015. Hence, the Company after the approval of the Board can file an application to National Stock Exchange of India Limited, for seeking reclassification.
